Non-Resident Hunting Preservation Fund, \$200 (payable to APHA) is due when booking.

A total of 50% will be due by January 1st prior to the hunt. The balance will be due 60 days prior to the commencement of the hunt. If it is necessary to cancel a hunt, client must give one year notice prior to the beginning dates of the hunt. Failure to do so will result in forfeiture of all deposits unless client is able to find a replacement hunter. If client gives a one-year notice of cancellation, 90% of all deposits will be refunded or 100% of all deposits applied to a future hunt. There will be no refund or compensation to the client if he or she arrives for the hunt late for any reason, including weather delays related to charter planes, or departs before the end of the hunt. Any possible legal action or dispute arising out of services provided by or through Litzen Guide Service or any of its employees, shall be governed by Alaska law and be litigated in the superior court for the State of Alaska in Kenai, Alaska.

Trip insurance is highly recommended.

Upon arrival at Litzen's lodge in interior Alaska, or Sand Point, Alaska: included in the hunt are food, all camp equipment, boats, guide, lodging, field preparation of meat and trophies, and all transportation during the hunt, and all private and federal land use fees. Not included are hunting/fishing licenses, big game tags, or the cost of air transportation services to and from McGrath, AK, the lodge or Sand Point, AK, meat processing or shipping of trophies. We will help with arrangements for shipping of trophies and make all arrangements for air taxi service from McGrath to the lodge. It is the client's responsibility to make flight arrangements with Reeve Air Alaska to McGrath for the interior hunts and Ravn Alaska to Sand Point for the coastal brown bear hunts. Litzen Guide Service will advise exact travel dates.

We are professionally qualified and experienced, but as a sportsman, you will understand that there can be no guarantee that you will secure the trophy you are seeking. There are a great many variables, some of which, like weather, are simply beyond human control. To a larger extent, your success is dependent on your mental attitude, physical ability and preparation.
